POLICE TRIAL.

Testimony Nearly Finished.

The first witness on the stand on Monday, December 19, was W. K. Greeley, a citizen, who testified that he saw a mounted officer hit on the head by a torch-can, while the officer was doing his best to keep his horse as motionless as was possible under the circumstances.

Henry J. Noble, '08, stated that he was struck on the head by a mounted policeman, and that he saw eight mounted men on the sidewalk.

G. C. Thomas, '05, told of seeing a woman clubbed by a policeman, on the green between the Rogers Building and the Natural History Building. Thomas told the policeman what he thought of him, and was himself clubbed in consequence. This proved valuable very evidence for the prosecution.

The first positive evidence of the presence of "the mucker" was given by E. W. Calkins, '05, who stated that he saw a torch and several stones thrown by "muckers" at the mounted officers.

The first man to be acquitted by the Board of Police of the charge of clubbing Tech students, was Sergt. D. F. Eagan, who told his detail to keep their clubs in their belts, and against whom there has not been a particle of evidence to connect him with the clubbing.

At Tuesday's session, Counsel Adams asked that Sergeants T. F. Goode and E. R. Taylor be discharged by the Board, for lack of evidence, but at the last moment the Board decided to hold its decision in their cases in abatement. The evidence in the case is to the effect that neither officer reached the scene until the trouble was over.

The last witness to be called for the prosecution was C. L. Rodgers, '05, who told of seeing several men struck by the police on the steps.

The sergeants without counsel were heard first, among whom was Sergeant W. T. Sheehan. Captain Hall, as the ranking officer, was called next. He gave practically the same testimony as at the previous hearing, stating that he drew his club only in self defence.

TECH HOCKEY RINK.

First Game Thursday.

The Hockey rink for the use of the Tech team is completed. Work was started on it about three weeks ago and has been rushed through so as to have it finished before the holidays. It is situated in the west end of the old Park Square Station train shed.

The rink is 150 feet by 65 feet and though not as large as some college rinks, it will amply serve for the use of the team. It is enclosed by a three foot board wall.

There is now on the rink about four inches of solid ice entirely free from air holes. The rink is lighted for the evening games by five arc lights.

Practice was started last Saturday and will be held every afternoon at four, except Saturday, when it will be at two o'clock.

The rink will be opened at 3 o'clock Thursday afternoon, with a practice game between Tech and Stone School. This will be the only game before the Christmas Holidays, and it is expected to draw a large attendance. Admission free. The rink can be reached from Providence Street by the west entrance of the station.

Exeter Club Smoker.

A regular meeting of the Exeter Club was held Tuesday night at the Union at 6.30 P.M. About twenty-five members and Professor Richards, '65, an old Exeter man, were present. Several new members of the Freshman class were taken into the club.

After the meeting the club adjourned to the small room where an informal supper was served. When supper was over, pipes were lighted and some of the musically inclined members of the club furnished music with guitars and mandolins. The meeting adjourned after Exeter and Tech songs and cheers had been given.

Basket Ball.

The Tech Basket Ball Team will line up against Worcester Tech at the Gymnasium at eight o'clock, Thursday evening, December 22. As at the last basket ball game at the Gym, the second team will play between the halves.

MINING SOCIETY.

Addressed By Dr. E. D. Peters.

One of the best attended meetings of the Mining Engineering Society was held last Monday evening at the Union. At the business meeting J. M. McMilden, '07, was elected to membership.

The speaker for the meeting was Dr. Edward Dyer Peters of Harvard who spoke on the "Commercial Side of the Art of Copper Smelting." Dr. Peters concerned himself wholly with the subject of copper smelting from a purely commercial standpoint. He gave some details of the process of smelting and outlined the use of the blast furnace in the extraction of copper from its different ores.

Dr. Peters' talk, interesting and instructive, was enjoyed by everybody.

Choice of Course.

Professors Lanza and Talbot addressed the Freshman Class Monday afternoon on their respective courses, Mechanical Engineering, and Chemistry and Chemical Engineering.

Professor Lanza emphasized the need of choosing a course wisely. He then described the work of the Mechanical Engineering Course, and the work of the engineer.

Professor Talbot explained the difference between Courses V and X, and also touched upon the different options of Course V. In concluding, he said that the man who completed his course to the satisfaction of himself and his instructors would find plenty of opportunities to secure a good position.

All Freshmen who intend to take Course IV are invited to meet Professor Chandler in the Architectural Lecture Room, in the Pierce Building, Monday, January 9, at 4.00 P.M. Professor Chandler will take the men on a tour through the rooms of the Architectural Department.
